New Rule

Proposed Rule
<p>All clubs will have the opportunity to purchase 3 additional race meetings once the calendar has been finalised and released. The option of purchasing additional meetings will expire once the insured number of meetings is fulfilled. These additional meetings will be at a fee set annually at the AIDKA Annual General Meeting. These meetings must also comply with the following conditions.</p> <ul style="list-style-type: none"> - Additional meetings must be submitted 30 days prior to the event. - All additional fees must be paid in full prior to the event.

- Additional meetings must not be on any weekend where another club within 250km has a race meeting on that same weekend.
- Must have approval from the Calendar and Events Committee

Clearly explain the new rule/changes requested.

Due to the remoteness of some clubs including TEDK, has resulted in the limited opportunities to compete in events during the season.

Effects of this include:

- Lack of meetings to qualify for titles before the close of for Titles (particularly in NT)
- Significant travel expenses to race in additional meetings.
- Lack of track time for new competitors. Clubs with neighbouring clubs, are often able to be signed off in 3 weeks with minimal state or southern interstate travel, rural and northern remote clubs, don't have such a luxury, whereby it can take a participant 6 meetings (often equating to 3 months within our past racing seasons).

TEDK would like to offer the ability to grow our sport and membership base, while keeping the activity affordable to those can't necessarily afford the time or expense of travelling interstate.

What situation/event/scenario has created this proposed rule change

Members struggling to get qualified for titles in time at remote clubs where the season is shortened due to weather and premises restrictions.
